1. Teams to consist of 5 pairs, confined to players of 15.5 handicap and over as at the 1st May 2021. The maximum effective handicap shall not exceed 19.4. Each round to be played off current handicap index subject to a maximum effective of 19.4. A player whose handicap index is reduced below 15.4 after 1st May 2021 is still eligible to play in the competition but must play off reduced handicap and concede additional shot /(s) where relevant. Players must belong to an Adult Category of membership of their club. Any breach of this rule as regarding a player's eligibility will result in disqualification of offending team.
2. In all Matches to the final the club at the top of the draw has three matches at home.
3. The final will be played on a two-leg home and away basis, with five matches in each leg. The first leg of the final shall be played on the course of the club at the top of the draw. Handicap indices will remain unchanged for second leg of the final.
4. All matches to be played to a finish except in the final. In the final half matches will count. In the event of a tie after the second leg of the final the last match alive shall play sudden death starting at the first tee.
5. Customary procedure of taking shots in fourball match-play will apply, I.E 90% of players course handicap.
6. Matches in each tie shall commence not later than 3.00pm, except for the two legs of the final when matches shall commence not later than 2.00pm.
7. The G.U.I. Local Rules and Tournament Conditions with regard to Distance Measuring Devices shall apply in accordance with the Rules of Golf handbook January 2019.
8. No extensions will be granted without reference to Committee who MAY grant an extension in EXCEPTIONAL CIRCUMSTANCES. Team managers shall exchange lists containing their teams' names in order of play and the names of substitutes at least ten minutes before start of play. The lists shall show current handicaps of all players and substitutes.
